Dear Fellow Sailor:

Mark your calendar for the return of the **GRAND CUP REGATTA** on April 26, 2008 sponsored by **Grand Lake Sailing Club, Grove, Okla.** For many years, this regatta was sponsored by the Grand Lake Yacht Squadron on the south end of the lake.

There will be a Spinnaker fleet and two Non-spinnaker fleets for monohull sailboats with either fixed or swing keels, 20 ft or longer. Trophies will be given to the top three places in each fleet and crew trophies will be given to the first place winners in each fleet.

- **Entry fee is \$25 per boat.**
- **Skipper's Meeting ~ 10am**
- **Races start at Noon**

Skippers are welcome to bring their boats to the club Friday night and to stay Saturday night

Facilities: Clubhouse and bath house available, paved ramp, camping and dock space
Motels are located in Grove a short distance from the club.

- Coffee & breakfast rolls will be served before the skipper's meeting.
- Refreshments will be served while race results are being calculated.

Directions:

- Club is located south of Grove, OK on Hwy 59. Turn west on E320 (Lake Road 6), go 1.5 miles to Grand Lake Sailing Club sign. It is the first right turn after the stop sign. Turn north, club is at the end of drive.
- By water, Grand Lake Sailing Club is in Dilar Cove, just inside Honey Creek East of The Peninsula (formerly Shangri La). Look for masts on south side.
